Industrial & Provident Society Board Elections

STAR would welcome members putting themselves forward for election to the Board of Reading Football Supporters' Society Limited (trading as "STAR" - Supporters' Trust At Reading) at its next Annual General Meeting in late August/Early September 2009.

In order to stand for election you need to be a current member of STAR and be aged 18 or over. You must be proposed and seconded by two other current members and have the support of a further 8 STAR members who are willing to back your candidacy. No STAR member may propose, second or support more than 3 different candidates.

Election Statement : You may provide an election statement of up to 250 words, typewritten, on a separate sheet of paper. This will give you an opportunity to set out your platform for standing, your interests and ideas you would like to implement if elected. STAR reserves the right to edit any statement over 250 words or containing factual inaccuracies or libellous material. All statements will be made available to STAR members and will be published on the STAR web site.

Disqualification : You cannot stand for election if you:

- have been a STAR Board member for 12 consecutive years;
- have been declared bankrupt or compounded with your creditors;
- are subject to a disqualification order made under the Company Directors Disqualification Act;
- have been convicted of an indictable offence;
- are or may on the basis of medical evidence be suffering from mental disorder;
- fail to abide by any of the rules for the conduct of elections made by the Board.
